NCFS Fixed Asset Users,

The Fixed Asset module of NCFS will remain open for FY24 entries until midnight July 21.

Asset transfers and asset retirements must be completed in the Fixed Asset module prior to midnight July 21.

Asset additions and asset adjustments should be completed in the Fixed Asset module prior to July 21 but can be backdated if deemed significant by OSC.

Note that significant additions and adjustments completed after July 21 will be reconciling items on your fixed asset reports. In addition, general ledger entries will be needed for FY24 and FY25 for the accrual ledger to account for the late entries.

We encourage you to review the <u>Year-End Checklist</u> and use it to track task completion throughout July 2024.
