Subject: 2016 Professional Ethics and Conduct Webcast

On July 28, 2016 from 10:00 a.m. to 12:00 p.m., the North Carolina Association of CPAs (NCACPA) will offer an ethics course by webcast exclusively for State government employees. This course, 2016 Professional Ethics and Conduct, will satisfy the State CPA Board's annual two-hour Ethics CPE requirement [NCAC 08G.0410 Professional Ethics and Conduct CPE]. To register for this webcast:

- Attendees **must pre-register** by clicking on the "Training" link at the top of the OSC web page (<http://www.osc.nc.gov>). The pre-registration deadline is June 29, 2016. (Payment **should not** be made at this time).
- On July 7, all pre-registered attendees will receive notification by email (from NCACPA) to register for this webcast. NCACPA will provide registration instructions and payment options in their email. NCACPA accepts payment by credit card (MasterCard, Visa, and American Express) and by check (payable to NCACPA). The registration fee is **\$50 per attendee**. Only those individuals who complete the NCACPA registration and payment process will be permitted to participate in this activity.

Jonathan Kraftchick, CPA, will be the course instructor. Mr. Kraftchick is a Director with Cherry Bekaert in their Raleigh office where he is responsible for overseeing much of the Firm's audit training, course development, and delivery. He has spent his career conducting audit engagements for a wide variety of companies and industries or writing and delivering courses both inside and outside of the Firm. He has also served as an adjunct professor at Elon University in their accounting department. He has received several awards for speaking including the NCACPA's Outstanding Seminar Discussion Leader award. Mr. Kraftchick received a Bachelor of Arts in Economics and a Master of Accounting from the University of North Carolina at Chapel Hill.

On November 9, 2016, from 10:00 a.m. to 12:00 p.m., the NCACPA also will offer a second ethics course via webcast, exclusively for State government employees. More information about this webcast will be forthcoming.
