Your Credit Card and Non-PIN Debit Card Transactions

A significant amount of the Discount Rates that we charge you for processing your Credit Card and Non-PIN Debit Card transactions represents charges that we must pay to the Issuing Banks (or that are otherwise charged to us by Mastercard®, Visa®, and Discover Network®), under Mastercard, Visa, and Discover Network (the Payments Networks) rules. This amount, called “Interchange,” varies based upon a complex series of inter-change levels that may apply to the transaction depending upon a number of factors – such as the type of card presented, specific information contained in the transaction, how and when the transaction is processed, your industry, and other factors.

Dues/Assessments Fee Schedule

For each sale transaction there is an Assessments Fee charged by Mastercard, Visa and Discover. The Mastercard Assessment Fee is 0.13% for transactions less than \$1,000.00. For consumer credit and commercial credit transactions greater than or equal to \$1,000.00 an additional 0.01% will be charged. The Visa Assessment Fee is 0.13% for consumer debit. For all consumer credit products the Visa Assessment Fee is 0.14%. For each B2B Virtual Payments Program transaction there is an assessment fee billed by Visa. The Visa Assessment Fee is 1.55%. The Discover Network Assessment Fee is 0.13%. The PayPal Assessment Fee is 0.10%.

Interchange Fee Schedule

Each Interchange level has an associated Interchange fee that is established by Mastercard, Visa and Discover Network. The schedule below shows the amount of the Interchange Fee that will be assessed for each transaction.

The amount of the Interchange Fee will depend on the type of transaction and the Interchange level at which the transaction is ultimately processed. In order to qualify for any specific Interchange level, you must satisfy certain qualification criteria established by the Payments Networks. The attached Interchange Qualification Matrix identifies the primary qualification criteria for the various Interchange levels.

Please note that the Payments Networks regularly add new Interchange levels, and change the rates and/or qualification criteria. Also note that the Interchange Fees shown below are in addition to any dues or assessments charged by the Payments Networks, as well as any other processing or transaction fees set forth in your fee schedule and/or merchant agreement.

The amount shown under “Rate” is multiplied by the amount of the transaction; the amount shown under “Per Item” is charged per transaction. Both amounts are included in the Interchange Fee.
