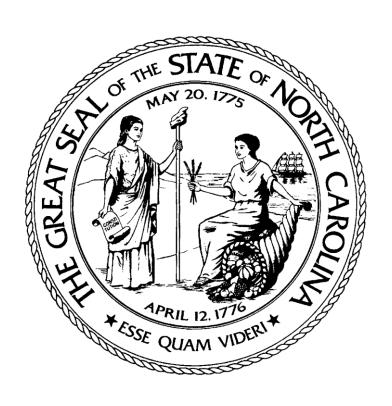

Introduction

The purpose of this report is to provide total information technology (IT) expenditures within the State as required by G.S. § 143B-1335 "Financial Reporting and Accountability for Information Technology Investments and Expenditures." This statute requires an annual report of IT operations and project expenditures coordinated by the Department of Information Technology (DIT) with the Office of State Budget and Management and the Office of the State Controller.

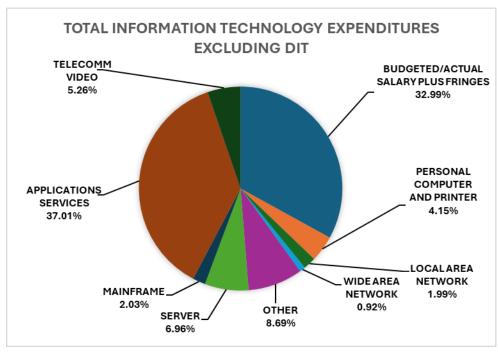
For this report, information technology budgeting and expenditures may include hardware, software, personnel, training, contractual services and other relevant items.

The General Assembly, the Judicial Department, and the UNC System are specifically exempted under G.S. § 143B-1320 from these requirements; however, due to readily available financial data in the North Carolina Financial System (NCFS), information for the Judicial Department and the UNC System is included in this report to provide a more complete picture of information technology expenditures in the State. Reporting at the project and application level is not available for these exempt agencies since they do not provide this information to DIT for inclusion in the Information Technology Portfolio Management System. When the State of North Carolina made the transition from the North Carolina Accounting System (NCAS) to the North Carolina Financial System (NCFS) in October 2023, institutional funds for Universities were not converted. Additionally, Universities are not to interface financial transactions from their institutional funds into NCFS with their monthly interface.

The basis for this report is the statewide chart of accounts and the personnel classification system. The primary sources of this data are the North Carolina Financial System (NCFS), the UNC System Data Mart, the HR-Payroll System, and the Information Technology Portfolio Management System. This report covers the period of July 2023 through June 2024 and includes all funding sources, with the exception of institutional funds for Universities.

Overview of IT Expenditures

Total IT expenditures (excluding DIT) were \$2,231,886,567 for fiscal year 2024. IT Expenditures for the Department of Information Technology totaled \$458,584,776 during the same period.

As can be seen in this chart, Applications Services contains the largest percentage of IT related expenditures at 37.01% of total IT expenditures.

The next largest categories of expenditures are Budgeted/Actual Salary plus Fringes (32.99%), Other (8.69%), and Server (6.96%). Remaining expenditures are broken down into the additional categories listed on Table 1-1, Information Technology Expenditures.

Report Methodology

Under the NCFS chart of accounts, most information technology operational costs are identified through specific account codes. The primary exception is personnel related costs that are recorded within NCFS in aggregate, without regard to the type of work performed by the position. These costs include salary, fringe benefits, and employee training expenses.

To estimate salary and fringe benefit costs associated with information technology positions, this report utilizes the class code structure within the HR-Payroll System. Budgeted salary for all permanent positions assigned an information technology specific class code is used to estimate each agency's personal services obligation for this fiscal year. The budgeted salary amounts include both vacant and filled positions. Personnel position information for the NC Education Lottery, NC Housing and Finance, and the UNC System are provided by the agencies themselves. If an agency's IT personnel do not fall into the class code structure the salary and fringe benefit costs could be understated.

Employee training costs for IT personnel cannot be compiled or estimated using NCFS, or the HR-Payroll System. These costs are not included in this report.

All other non-personnel costs are grouped into reporting categories as follows:

Summary of IT Expenditures

<u>Table 1-1 Information Technology Expenditures</u> lists by agency, the total IT expenditures grouped into major cost categories. The amounts listed are total costs, without regard to the funding source. Budgeted salary amounts plus calculated fringe benefit cost amounts are used to represent total salary cost, which means that the cost is overstated by the amount of lapsed salaries generated by vacant IT positions. Since the UNC System (except School of Science and Math) now reports actual personnel expenditures, their numbers are not overstated. As a primary IT services vendor for most agencies, the Department of Information Technology is shown separately and is not included in the report totals.

Table 1-2 Information Technology Expenditures – Information Technology Portfolio

Management System Detail Cost Categories lists by agency, the total IT expenditures grouped into the detail cost categories used in the Information Technology Portfolio Management System. The amounts listed are total costs, without regard to the funding source. As a primary IT services vendor for most agencies, the Department of Information Technology is shown separately and is not included in the report totals.

<u>Table 1-3 Information Technology Expenditures - UNC System</u> lists the UNC System by the total IT expenditures grouped into major cost categories. Costs are segregated into the same categories as used in Table 1-1.

<u>Table 1-4 Percentage of IT Expenditures to Total Expenditures</u> lists, by agency, the percentage of total IT expenditures compared to total expenditures, without regard to funding source. Total expenditures are calculated based on logic used to prepare the BD701-Agency Management Budget Report. Intragovernmental transactions are not included in an effort to avoid overstatement of total expenditures across funds.

The 911 Distribution Fund managed by DIT is shown separately since it is not a primary function of the agency. The combination of both categories will equal the DIT total as reported on tables 1-1 and 1-2.

Budget to Actual Comparison and Current vs. Prior Year

<u>Table 3-1 Information Technology Expenditures - Budget to Actual Comparison</u> provides an indication of budget utilization for IT expenditures as of the end of the report period. A 100% utilization rate indicates that the agency spent their entire budget by fiscal year end.

The total budget estimate is calculated using budgeted salary information and the authorized budget amounts as posted within NCFS for the non-salary cost categories.

This table does not include the UNC System, the Department of Transportation, the North Carolina Global TransPark Authority or the North Carolina State Ports Authority. These agencies are allowed to post budgets at a highly summarized level; therefore, none of the budget can be identified within NCFS as related to IT cost categories.

<u>Table 3-2 Information Technology Expenditures – Current Year versus Prior Year</u> provides a comparison to prior year expenditures.

During Fiscal Year 2024, the North Carolina Community College Systems Office engaged in an ERP Modernization Project, which led to a direct increase in their information technology expenditures.

Prior to 2023, the North Carolina State Bureau of Investigation (SBI) and the North Carolina Department of Adult Correction (DAC) were part of the North Carolina Department of Public Safety (DPS). In January 2023, DAC split from DPS and officially started operations. In December 2023, SBI split from DPS and became an independent cabinet level agency.

During Fiscal Year 2024, the State Board of Elections saw an increase in information technology expenditures due to the purchase of printers, warranties, shipping costs, and software subscriptions.

<u>Table 3-3 Information Technology Expenditures – Current Year versus Prior Year – UNC System</u> provides a comparison to prior year expenditures for the UNC System. In October 2023, the State of North Carolina made the transition from the North Carolina Accounting System (NCAS) to the North Carolina Financial System (NCFS). When the State transitioned to NCFS, institutional funds for Universities were not converted, and Universities are not interfacing financial transactions from their institutional funds currently into NCFS. For Prior Fiscal Year 2023, the UNC System reported a total of \$203,756,879.59 in information technology expenditures using institutional funds. As a result of this exclusion, for Fiscal Year 2024 the UNC System is reporting a decrease in their total information technology expenditures.

Portfolio Management

For many years, the State of North Carolina grappled with the question, "How much does the state spend on information technology each year?" The General Assembly mandated that this joint report be prepared to begin answering this question.

In 2004, the General Assembly directed the State Chief Information Officer (SCIO) to begin improving the management of information technology in state government. In 2015, the Department of Information Technology (DIT), implemented a new Information Technology Portfolio Management System to replace the outdated system. A key capability is to accumulate IT expenditures for each project, by integrating data from the North Carolina Financial System (NCFS) and DOT's SAP System. In accordance with the statutory authority of the SCIO and DIT, this section focuses only on the Executive Branch. No figures are provided for the University System, the Administrative Office of the Courts, or the General Assembly.

What is Portfolio Management?

Portfolio Management (PM) is the grouping of computer applications and projects to examine an organization's spending, risk profile, and plans for technology. Just as one manages a personal retirement fund or budget, the state manages its technology portfolio for the future. It does this by managing IT investments from the agency, program (closely related projects with common business goals) and statewide perspectives to maximize citizen benefits and public value for costs within acceptable risk profiles. The intent is to build and maintain project and application portfolios that reflect the value of the investment and aid the agency in optimizing business decisions about technology.

The state's technology profile is composed of several key elements: projects, existing applications, people, hardware, and software. Other sections of this report give information on the costs of personnel and hardware and software. This section addresses projects and existing applications.

Project Portfolio Management

Project Portfolio Management (PPM) focuses on **new** technology projects intended to improve the delivery of existing services or to provide new services. Projects have a definite timeline, a budget, and a set of deliverables. When they are completed, the state should have a new service, application, or improved infrastructure to build on for the future.

Projects:

The Enterprise Project Management Office (EPMO), under the SCIO, monitored the initiation, execution, and closeout of over 115 projects during FY 2024. IT Projects represent new efforts with budgets, timelines, and milestones. Costs for these projects are included in this report as captured in the Information Technology Portfolio Management System. State agencies (including DIT) executed approximately \$151.2 million on IT projects.

Chart 1.1 shows FY 2024 project costs by the source of funds (excluding DIT).

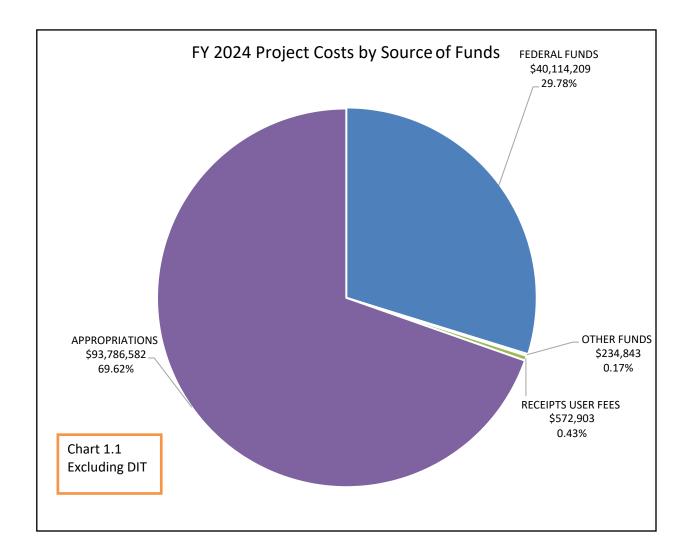
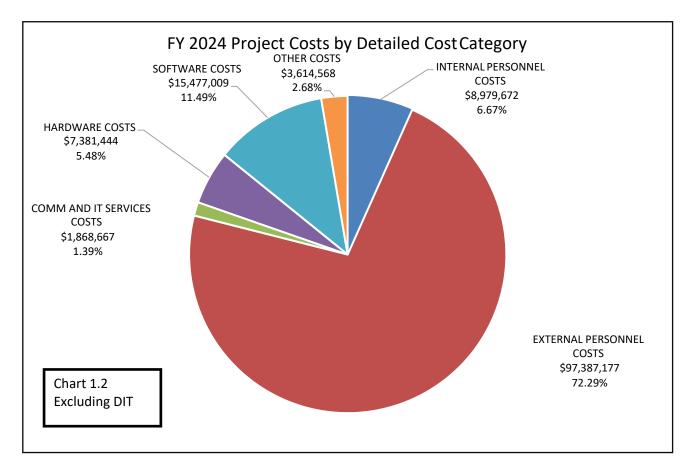


Chart 1.2 shows the distribution of project funds statewide at a detailed cost level (excluding DIT).

Application Portfolio Management

Application Portfolio Management (APM) allows IT organizations to inventory and clearly visualize their current state of applications, understanding their fit and value to the business, public services provided, and citizens served. Organizations can then align applications, technology landscape, business capabilities, and strategy into a comprehensive and actionable roadmap in support of business operations.

The Department of Information Technology (DIT) works with state agencies to plan and coordinate information technology efforts and resources, in part through collection of IT application portfolio information, NCGS 143B-1321(a)(17). This approach provides insight and understanding into how IT applications align with and support agency strategic objectives, how services are delivered to citizens, how to optimize portfolio value, and how data-driven decisions are made.

Having a 360-degree view of agency portfolios for Agency CIOs can be helpful for developing and administering comprehensive planning and management, facilitating more efficient and economic use of IT assets and resources, and remaining agile in adapting to changing IT landscapes.

Report Methodology

All application data submitted to DIT is self-reported by Agency CIOs and their staffs for their agencies. Application attributes and costs are currently captured through the annual data collection activity after each fiscal year concludes. Agency CIOs are responsible for ensuring the accuracy, reliability, completeness, timeliness, and usefulness of the data reported. Cost categories were developed with assistance and approval of the Office of the State Controller (OSC) and Office of State Budget and Management (OSBM) and include unique cost centers in the North Carolina Financial System (NCFS). The Department of Transportation (DOT) uses the SAP System.

DIT encourages agencies to review their internal reporting practices consistent with statutorily mandated reporting requirements. Questions regarding data in this section of the report should be independently verified with the reporting agency.

Annual notice is sent by DIT's Secretary and State Chief Information Officer to Agency CIOs. DIT's Enterprise Portfolio Management (EPM) Services group provides support to agencies to submit their data. Published training materials, resources, and staff are made available to support this effort.

Availability of Data

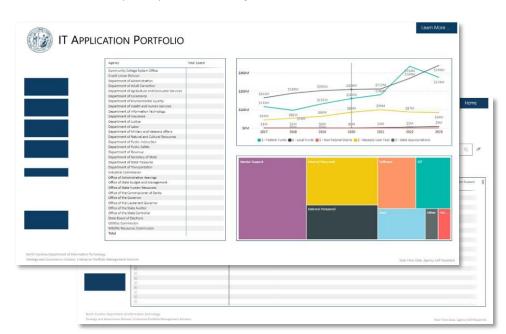
DIT makes information provided by agencies available pursuant to general statutes and as a public service in providing greater transparency in government services and spending. In 2019, DIT started publishing real-time agency application cost data to its public website using interactive dashboards, available at https://it.nc.gov/resources/it-application-portfolio-management.

In 2023, DIT upgraded the service platform used to collect annual agency submissions. The upgraded platform with enhanced reporting capabilities continues to serve as the official system of record for data reported to OSC and OSBM and compiled for use in its official report to the General Assembly. Data cannot be changed for previous years after reporting windows have closed.

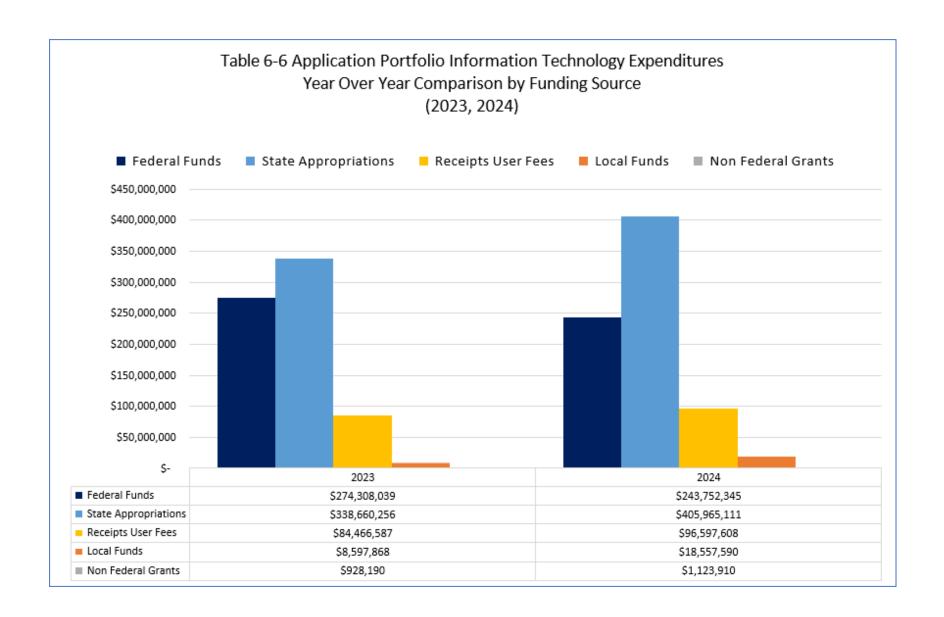
Table 6-5 Application Portfolio Information Technology Expenditures Year Over Year Comparison by Agency

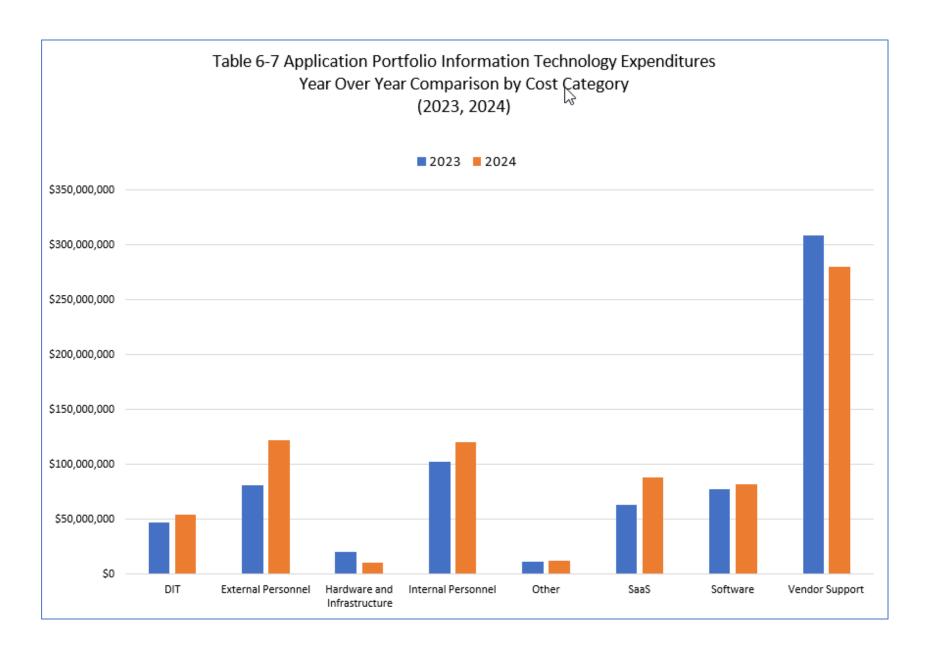


Figure 1-1 Annual Reporting of IT Application Portfolio Information Notice to Agency CIOs, June 19, 2024

Closing

As in previous years, the information for this section of IT Expenditures Report is from the Information Technology Portfolio Management System. The cost categories were developed with the assistance and approval of the Office of the State Controller and the Office of State Budget and Management. With the new system, costs have been identified using unique costs centers in the North Carolina Financial System (NCFS) and for Department of Transportation (DOT), the SAP System. For NCFS projects, the internal personnel numbers are based on self-reported data from the agencies. This is because the agencies are not setup to track internal agency personnel hours and associate those hours with an IT project in the HR/Payroll System. These internal personnel costs have not been audited, nor were they directly transferred to the Information Technology Portfolio Management System from NCFS. Overall, approximately 55.98% of the costs shown in Table 1.1 (less the AOC, the University system, NC Education Lottery and Department of Information Technology) are represented in the above charts and tables.
